

## Why NABBI?

The name National Association of Bail Bond Investigators was owned by someone already and they offered it to the association gratis at the previous formulation meeting in Las Vegas and it was voted on and accepted by the majority present. The name reflects the true nature of the bail bond recovery agent.

## What makes NABBI different from other organizations?

This association is predicated on giving a voice legislatively to Bail Enforcement professionals by and through a non-profit corporation. This differentiates us from for profit organizations owned by individuals to promote themselves, their school or similar situations. NABBI is a 501(C)(6) non profit industry advocacy association.

## Why should I pay for something that is not established?

We are now established and you would have the opportunity to influence our association’s ideals and unification processes.

## How much is it really going to cost me.?

Annual membership is \$100. Any cost involved, is an investment to protect and save our profession. Membership dues can only be changed by a vote of the members.
